## **REFRAMING GLOBAL DEMOCRACY**

Among the noteworthy speakers at the recent CGS national meeting in Minneapolis was Didier Jacobs, author of *Global Democracy* ([http://www.vanderbiltuniversitypress.com:80/bookdetail.asp?book\\_id=4114](http://www.vanderbiltuniversitypress.com:80/bookdetail.asp?book_id=4114)). One proposition of this brilliant book is that the United Nations, the International Monetary Fund, the World Bank, and the World Trade Organization together form our current global government, albeit an ineffective one. But it is the global government that the permanent members of the Security Council want: a “weak confederation,” with veto and opt-out privileges for a select group of powerful nations, the so-called P-5, and a “federation,” with no veto and no opt-out privileges, for all others.

Mr. Jacobs asserts, only slightly tongue-in-cheek, that the global government we already have is characterized as a system of apartheid, in which one’s position in the pecking order is determined by the color of one’s passport.

Among the take away points in *Global Democracy*’s conclusion are:

- Institutions are essential (“Governance without government” is, at best, nonsense)
- “Global democracy is a big idea that is astonishingly easy to communicate: ‘We believe all people should have equal say in decisions that affect all of them’ ‘The World Trade Organization is not democratic and that is not OK.’ … ‘The Security Council does not have proper checks and balances; that’s bad in national politics, it’s also bad in world politics.’”
- In our everyday conversation we can promote global democracy by referring to the UN or the WTO as “our global government.” But this is not enough; eventually ordinary citizens will rightfully expect to elect their representatives in that government.
- The peace movement needs to form and promote a long-term strategy for change (even in between unpopular wars) instead of abdicating that role to nationalist and benevolent imperialist think tanks.

Reframing the Global Solutions debate in this way is worth considering in spite of the risk that it will be seen by some as excessively ambitious. As we slide well into the 21<sup>st</sup> century it’s time to reframe our stand on how we can solve such seemingly intractable global problems as environmental degradation and nuclear

arms, among others, that are beyond the capacity of the currently undemocratic “global government” to manage effectively.

### **HIV/AIDS, 2008, THE GLOBAL SITUATION**

This talk will examine the epidemiology of HIV/AIDS at the global, national and local levels. It will note current trends in the spread and treatment of the disease and consider what more can be done by the US and globally to prevent its spread and treat existing victims. The medical, economic, and socio-political dimensions of the problem will all be analyzed.

**Presenter:** KEITH HENRY, M.D. A practitioner at the Hennepin County Medical Center and a professor of medicine at the University of Minnesota, Dr. Henry received his MD from the University of Illinois, Chicago in 1978 and trained in internal medicine in St. Louis from 1978-81. He held a fellowship on infectious diseases at the University of Minnesota (1984-87) and established the state's first HIV clinic in 1985 and has since focused exclusively on HIV care and clinical research. He has published more than 100 papers and abstracts on his specialization and has a wealth of relevant domestic and overseas experience.

Following a career with the Minnesota Education Association, **BERNARD** became a virtually full-time peace and justice activist. A past Board member of CGS MN, he has also served the Minnesota Alliance of Peacemakers (MAP) in numerous capacities and was as its President for the past three years, a period in which MAP witnessed truly remarkable growth. **BRAUN** has been associated with Women Against Military Madness for 25 years, is a co-founder of WAMM's Iraq Committee and is active with several other groups working on Iraq. She was named “Activist of the Year” by the Minnesota Alliance for Progressive Action in 2003 and, along with her husband John, was a co-recipient of a 2006 peace and justice award from the Hawkinson Foundation. **DILLON** is active in various justice, peace and sustainability issues at the Basilica of Saint Mary and elsewhere in the Twin Cities. He represents the Basilica in MAP; serves on MAP's Executive Committee, the Steering Team of the Network of Spiritual Progressives and the Board of the MN Chapter of CGS; and chairs the Peace Island steering committee.

Joe Schwartzberg's paper, "Universal Regional Representation as a Basis for Security Council Reform" (presented in June 2007 at the annual meeting of the Academic Council on the United Nations System in New York) was published in the November number of *The Federalist Debate* (vol. XX, no. 3, pp. 17-21). This well-edited journal, published three times per year in Turin, Italy, provides news relating to federalism in Europe and the world as a whole and offers a stimulating forum for relevant opinions and new ideas (see item on page 4). Board members Myron Kronisch and other CW/PS supporters have constituted themselves as "Ambassadors for Weighted Voting" and have been visiting foreign ministries, the media and NGOs in national capitals on five continents as well as national missions at the UN to promote the idea. Joe has been doing much the same thing during trips to New York in June and to Europe in August. He finds that his ideas are being given careful consideration in many quarters. They have been prominently noted in scholarly works in English, German, Italian and Czech and a brief version (five-pages) of his Security Council paper has been translated in Beijing into Chinese.

## **BOUTROS-GHALI: DEMOCRATIZATION AT GLOBAL LEVEL NEEDED**

“In a message addressed to the supporters of the Campaign for a UN Parliamentary Assembly in May 2007, Boutros Boutros-Ghali, former UN Secretary General, said: ‘If the process of democratization does not move forward at the international level, democracy at the level of the nation-state will also diminish. In the process of globalization, problems which can only be solved effectively at the global level are multiplying and requirements of political governance are extending beyond state borders accordingly. Increased decision-making at the global level therefore is inevitable. We need to promote the democratization of globalization, before globalization destroys the foundations of national and international democracy.’ According to Boutros-Ghali, ‘the establishment of a Parliamentary Assembly at the United Nations has become an indispensable step to achieve democratic control of globalization.’”

(Much is happening in regard to a World Parliamentary Assembly of which most Americans are totally unaware. We hope to explore this theme in a future CGS MN Newsletter and perhaps in a Third Thursday Global Issues Forum.)
